## PUBLIC NOTICE GLOUCESTERSHIRE COUNTY COUNCIL ON-STREET PARKING ORDER 2017 (VARIOUS ROADS, KEMBLE, COTSWOLD DISTRICT) (VARIATION) ORDER 2022 – MODIFICATION NOTICE

Between 12<sup>th</sup> May and 9<sup>th</sup> June 2022 Gloucestershire County Council advertised its intention to make the above Variation Order under the Road Traffic Regulation Act 1984, the effect of which would vary the Gloucestershire County Council On-Street Parking Order 2017 by introducing waiting and stopping restrictions within Kemble, Cotswold District, Gloucestershire.

Representations were received to the proposals and in response to some of these representations it is now the Council's intention to modify the original extent of the proposed restrictions on Windmill Road, by extending the restrictions as outlined below and shown on the associated consultation plan:

## Proposed Waiting Restrictions - No Waiting at Any Time

Road Name, Number	Extent
Windmill Road (C179)	Along sections on both sides of its carriageway north of its junction with Kemble Road (A429) up to the point it passes under the Railway Bridge.

The remainder of the GLOUCESTERSHIRE COUNTY COUNCIL ON-STREET PARKING ORDER 2017 (VARIOUS ROADS, KEMBLE, COTSWOLD DISTRICT) (VARIATION) ORDER 2022 proposal will remain unchanged as originally advertised in May/June 2022.
