## Minutes of the Meeting of the Parish Council held on Tuesday April 11, 2023 at 7pm in the Village Hall

Kemble Park: Resident queried as to whether it is a registered community asset. It was noted that it is recognised by English Heritage.

Community Garden: Resident seeking update – advised awaiting heads of terms from CDC

Community Fund from Solar Farm – Andy Tait provided some information regarding such schemes following his work on the Wroughton Solar Farm scheme.

- **22.194.** To approve the minutes of the meeting held on March 14, 2022 It was proposed to approve the minutes as a true and accurate record. This was seconded, all remaining councillors voted to agree and the matter was resolved.
- 22.195. To review and agree actions required regarding updating of NDP including review of the Historic Environment evidence at a cost of £750 plus VAT. It was proposed to approve this payment in order to update review of evidence. This was seconded, all remaining councillors voted to agree and the matter was resolved.
- 22.196. To agree actions required for publication of the Annual Report It was proposed the clerk pull together the report and arrange printing ready for distribution by councillors ahead of Annual Meeting of Parish on May 30, 2023. A spend of £500 for B&W printing was approved. This was seconded, all remaining councillors voted to agree and the matter was resolved.

To receive update on negotiations for renewing Playing Field lease Cllrs Silk & Pettitt attended a meeting with Bathurst to discuss and it was proposed to seek to extend the existing lease for 1yr pending discussions to secure the future of the site. This was seconded, all remaining councillors voted to agree and the matter was resolved.

This was seconded, all remaining councillors voted to agree and the **matter was resolved.**

space in Kemble is very limited & also discussed footbridge across drainage channel on Thames Path to west of A249
